A New Geo-Political World Order is Emerging

These last 10 days have seen a seismic shift in global power relations. I want to give you an analysis from both the prophetic shift and the crisis and solution facing South Africa and Southern Africa.

I along with the rest of the world were staggered by the recent speeches made by the US secretary of Defense, the Vice President at the Munich Security Conference, the meeting in Riyadh of America and Russia to start peace negotiations and president Trump's public withdrawal of support for Ukraine and Zelensky in particular.

I had to listen to Vice –President JD Vance's short 22 minute speech twice it was so stunning in its accusation that Europe has become a tyranny to its own population. He told them straight out the enemy is not from across the borders (Russia) It is inside Europe. He castigated them for denial of free speech rights. He had several examples of how bad this had become. The most notable example: In the UK a man was praying silently 50 meters away from an abortion clinic not bothering or speaking to anyone. When the police asked him what he was doing he said he was praying silently for the child he and his girlfriend had aborted. He was arrested by the police.

At the closing of the Munich Security Conference (attended by the political and military elite) the conference chairman couldn't close the conference from the podium as he had started crying (I kid you not!). He realized America was in process of turning its back on Europe and opening a strategic relationship with Russia.

JD Vance did let them know that at the coming peace talks with Russia on ending the Ukraine conflict Europe would not be invited to participate. There is an old saying, if you are not sitting around the table then you are on the menu. Hence the tears.

The reopening of US-Russia dialogue has triggered alarm, especially in Western Europe, where many see it as a potential repeat of Yalta — a grand power settlement taking place over their heads. Much of the commentary has been exaggerated. Yet, the pace of global change has clearly accelerated. The words and actions of US President Donald Trump, Vice President J.D. Vance, and other key Republican figures over the past ten days suggest that Washington has stopped resisting the shift to a new world order and is now trying to lead it.

Trump's vision for North America is straightforward: from Greenland to Mexico and Panama, the entire region will be firmly bound to the US, either as part of its economic

engine or under its military umbrella. Latin America remains an extension of this sphere, Western Europe, however, is another matter. From Trump's perspective, the continent is now a competitor and America is wooing their industries to relocate – especially their auto industries. The new US stance is clear: Europe must pay its way, both in military and economic terms. Trump and his team see the European Union not as a great power, but as a weak and divided entity that clings to illusions of parity with the United States.

NATO, meanwhile, is viewed as a tool that has outlived its purpose — one that Washington is willing to use, but only under its own terms.

This wider geopolitical context frames the latest shifts in US-Russia relations. Trump appears to have concluded that his predecessors — Joe Biden and Barack Obama — made critical miscalculations that pushed Moscow into China's orbit. By aggressively expanding NATO and isolating Russia through sanctions, Washington inadvertently strengthened a Eurasian bloc that now includes China, Russia, Iran and North Korea.

Trump has recognized the failure of Biden's Ukraine strategy. The goal of delivering a “**strategic defeat**” to Russia — militarily, economically, and politically — has failed. Russia's economy has withstood the unprecedented Western sanctions, its military is stronger, its economy has adapted, and Moscow remains a pivotal global power.

Now, Trump is seeking a settlement in Ukraine that locks in the current frontlines while shifting the burden of supporting Kiev onto Europe. His administration also aims to weaken Russia's ties with Beijing, Tehran, and Pyongyang. This is the real logic behind Trump's outreach to Moscow — it is less about making peace with Russia and more about repositioning America for the long game against China.

However, a new world order is emerging.

This order will be layered, with different power centers playing distinct roles. At the global level, a quadrangle of America, China, India, and Russia will dominate. Below that, regional and continental blocs will form, with key players — Western Europe, Brazil, Iran, and others — vying for influence within their respective spheres.

It is within this new emerging world order that South Africa and in fact Southern Africa needs to build its regional economic and political sphere of power and influence. But we will need to realize we need to create the new world power player that other regions are forming.

The Techno-Civilizational State (shortened to TCS)

In researching the new emerging world order of a multi-polar world what stands out is the realization that the borders of the world will be defined by culture and strategic autonomy. That is a region that has a defined culture, resources, technology and power.

The roots of this idea of the TCS lie in the emergence of technology joined with the older developments of industry in a vision of a society governed not by politicians or financiers but by scientists and engineers, guided by the principles of efficiency, technological mastery, and resource optimization. In the worldview of early technocrats, economic systems based on arbitrary currencies and speculative markets were seen as chaotic relics of the past. Instead, they proposed that energy itself – measurable and quantifiable combined with technology should serve as the basis for all economic transactions. This new power of information technology would thus become a self-contained and self-sustaining entity, where wealth is defined by the availability of natural resources, the expertise of its inhabitants, and the seamless integration of technology with governance.

Then you combine all that with civilization culture that defines the values of the people and you have the making of TCS. That is what is emerging in America, China, Russia, Japan, India.

However, the TCS was never envisioned as something that could be established in just any location. It required a very particular environment – one with abundant natural resources, advanced industrial infrastructure, and a population trained to navigate the demands of a highly mechanized society. The ideal setting, according to early technocratic theorists, was North America, with its vast mineral wealth, fertile lands, and unmatched potential for hydroelectric and industrial power. Canada, with its rich deposits of metals and minerals, and Greenland, with its untapped reserves of rare earth elements, were integral to this vision. The Panama Canal, as the lifeline connecting the Atlantic and Pacific oceans, would further ensure the region's strategic autonomy from global supply chains.

From this perspective, Trump's desire to acquire Greenland and secure control over the Panama Canal becomes less eccentric and more of a calculated step towards fulfilling a technocratic vision that has long been dormant but never entirely forgotten.

Most political analysts initially interpreted Trump's focus on these regions as part of his broader strategy of retrenchment, aimed at reducing US involvement in overseas conflicts and reorienting national priorities inward. They saw his rhetoric about Canada and Greenland as either bluster or opportunistic real estate maneuvering. Yet, when viewed through the lens of technocratic theory, a different logic emerges. Trump's America, despite its rhetoric of self-sufficiency, cannot achieve industrial independence with its current resource base. The energy-intensive industries that would power a new era of American greatness require access to mineral reserves, cheap power, and strategic shipping routes. Canada's vast natural wealth, Greenland's potential as a future resource hub, and the Panama Canal's role as a vital artery of trade are not peripheral concerns – they are central to the construction of a modern TCS.

For all his bluster and unpredictability, Trump's overarching aim of "*making America great again*" fits seamlessly into this framework. By 2025, it seems, key figures in his administration have recognized that achieving this vision would require more than tax

cuts and deregulation. It would demand the strategic acquisition of resources and infrastructure beyond America's current borders – assets that could allow a new era of technological and industrial expansion. The TCS in this context, is not merely a speculative ideal but a pragmatic blueprint for securing national prosperity in an increasingly multipolar world.

In this type of analysis it is evident that Europe loses out on all the necessary elements of a long term sustainable TCS. They have no energy resources or strategic mineral resources. Thus the ancient dream of Napoleon, Hitler and many others...collapse Russia and loot the strategic resources that it possesses. An fighting Russia to the last Ukrainian was a necessary part of this strategy.

It all failed. And America delivered the post mortem to the EU this last week. The war is over and the EU has lost. America will now make a strategic deal with Russia as to how Ukraine will be divided.

Africa Beware!

It is time for Africa and especially Southern Africa to wake up. BRICS is not a safety net for us. Nations do not have friends, they have interests.

Regardless of all the fine rhetoric of BRICS solidarity or G20 attendance we are not part of the international power players. We are not sitting at the strategic table...we are on the menu.

Southern Africa, East Africa, West Africa all need to form new regional power blocks to advance as Techno-Civilizational States. The world power centers want us divided into weak 54 states, play off each against the other, promote ethnic divisions, buy off politicians and parties and then strip us of energy and mineral resources.

That is the danger ahead and it will not be stopped by special envoys to Washington pleading our case or begging China to invest or Russia to allow us a seat at the BRICS table. That is all for show. And it seems our politicians love the international conferences, the first class travel, 5 star hotels.

None of that will rescue our desperate poverty and failing economies and the world power players have no sympathy for our plight.

We need to start thinking and planning strategically for the creation of Christian Civilizational Super State of Southern Africa. There is a blueprint for it in scripture.
