A New Eschatology for a New BRICS World Order

This week 36 nations gathered in Kazan Russia for the international BRICS summit. The decisions taken there will create a future new multi-polar world order with a new economic system to rival the G7 West. It will also require the church of the Global South to envision a new Eschatology for this new Multi-Polar World Order.

The world order of power relationships changed dramatically this week in Kazan Russia with the BRICS summit making major moves to create a new world order.

This important event needs an analysis from a perspective of what does this mean for the Kingdom of God agenda on earth for the future. Our problem for the charismatic evangelical church is that more and more of world events are not compatible with the current "end times" narrative from our pulpits.

So I am going to give you a quick analysis of what happened this last week at the BRICS meeting in terms of who was there, what were the major themes and decisions of this new world alliance and then I want to give you my analysis of how this impacts our vision of the times we are now living and the impact on the need for a new eschatology.

The 16th BRICS Summit

The previous international BRICS yearly leadership was under President Cyril Ramaphosa of South Africa and the new yearly leadership will now rotate to Russia where Russia set the future agenda for the BRICS alliance

The 16th BRICS Summit, held in Kazan, Russia from October 22-24, 2024, brought together leaders from Brazil, Russia, India, China, South Africa, and new member nations to discuss key global economic and political issues. As reported by Reuters, the summit focused on strengthening multilateralism, reforming global financial systems, and expanding the use of local currencies in international trade, signaling the bloc's growing influence in shaping a new world order.

The 16th BRICS Summit marked a significant moment in the bloc's efforts to reshape global governance and promote a multipolar world order. With 36 countries in attendance, including new members, the summit highlighted BRICS' growing influence and its challenge to Western-dominated institutions.

The summit saw participation from 36 countries, with over 20 represented by heads of state. Core BRICS members Brazil, Russia, India, China, and South Africa were joined by new full members Iran, Egypt, Ethiopia, and the United Arab Emirates, who officially joined on January 1, 2024.. Other notable attendees included leaders from

most of the nations in attendence. This expanded representation significantly increased BRICS' global influence, with the bloc now encompassing about 41% of the world's population and 24% of global GDP. 14 nations were granted "Partnership" status and the other more than 30 countries who have expressed interest to join will have to wait until the present grouping have established some of the economic structures.

Challenging Western Dominance

The summit emphasized BRICS' role as a counterweight to Western-led institutions and the U.S.-dominated global order. Leaders called for reforms in global governance structures to better represent the interests of the Global South and create a more equitable international system.

Russian President Putin declared the formation of a "multipolar world order" as ongoing and irreversible, reflecting the bloc's ambition to reshape global power dynamics. This stance was further reinforced by discussions on alternative financial mechanisms, including a BRICS-led international payment system, aimed at reducing reliance on Western financial systems and the U.S. dollar

Economic Impact of BRICS

With a combined GDP surpassing \$60 trillion, the BRICS nations now outpace the G7 economically. The bloc's projected growth rate of 4% by year-end exceeds the global average of 3.2%, demonstrating robust economic momentum

This economic strength positions BRICS as a significant force in shaping global economic policies and development trajectories, particularly in addressing the concerns of emerging economies and the Global South

Financial Architecture Reform

A key focus of the summit was the urgent need for comprehensive reform of the global financial architecture. Leaders emphasized enhancing the representation of developing countries in international financial institutions, aiming to create a more equitable system

The declaration called for strengthening financial cooperation among BRICS nations and expanding the use of local currencies to promote economic stability and development. This push for reform reflects the bloc's growing influence and its desire to reshape global economic governance structures in favor of emerging economies.

Cross-Border Payment Initiatives

The BRICS Cross-Border Payments Initiative (BCBPI) emerged as a key focus, promoting the use of local currencies in international trade and strengthening banking networks for seamless transactions

This initiative aims to reduce dependence on Western-dominated financial systems and enhance economic sovereignty among member nations. Additionally, the summit

introduced BRICS Pay, a debit card system similar to China's AliPay, which underwent its first trial run during the Business Council meeting

These developments signify a concerted effort to create alternative financial mechanisms that can operate independently of existing global payment infrastructures like the SWIFT international payment system which America and the European Union have weaponized as a method of economic dominance.

Strategic Leadership and Cooperation

Under the supervision of Russian Deputy Foreign Minister Sergey Ryabkov, the summit's preparations involved meticulous planning and multiple preparatory meetings of finance ministers, central bank governors, working groups, and the Business Council

The gathering emphasized strengthening multilateralism, counter-terrorism efforts, and addressing Global South concerns.. Notable initiatives included the BRICS Startup Forum to promote innovation and technology transfer.

The summit also welcomed India's candidacy to host COP 33 in 2028 and endorsed the G20 New Delhi Declaration, highlighting the bloc's commitment to environmental and developmental programs.

A Reassessment for the Church and the Kingdom of God

If you are captive to an eschatology and vision of the future that believes....

- 1) The world is moving towards an international One World Government
- 2) That the world will be run by an Antichrist from (take your pick) the Revived Roam Empire of the European Union or a Muslim out of Islam
- 3) That we will have a single world currency and you wont be able to buy or sell unless you have the mark of the Beast
- 4) That a Russian led alliance will invade Israel to capture great wealth.
- 5) That there will be a great Chinese horde that will invade the West.
- 6) That the current nation of Israel and Jerusalem will fulfill the prophecies of Isaiah 62:7 (see www.isaiah62fast.com) Jerusalem and Israel to be a "praise in all the earth" with the nations coming to Israel to ask "teach us your ways"

.....then what happened this last week in Kazan Russia fits none of your prophetic expectations. Let me comment briefly on of the 6 prophetic expectations in the light of a new changing world order:

- 1) The world is not moving to a One World unipolar government. The new international order is moving to a multipolar world order that respects individual national sovereignty and differing cultures.
- 2) The agreement among the BRICS nations is that this is not a military or political unity or alliance. It is a new agreement among nations relations will be governed by mutually agreed upon treaties of international law that will create stable and fair economic relations without one nation or alliance dominating by force and power. There is not room here for any of these

- nations to submit themselves to some international new charismatic "Hitler" running the world.
- 3) There is no one world currency coming. There is not even a "BRICS" currency envisioned. Instead the emphasis will be setting up a mechanism for nations to trade with each other using their own currencies where possible and the dollar as less as possible.
- 4) There is no great Russian Gog Magog invasion of Israel coming. Russia has enough problems just projecting power across here border with Ukraine than thinking they have the military capacity to move armies all the way to Israel or that Israel has anything that Russia needs.
- 5) There is no great Chines army coming to invade the West. What is coming out of China and invading the West are goods and products and for that China needs customers and peace in the world. You don't shoot and bomb customers, you need them to buy your goods and be able to sell you their goods. This is "economic war" and they are verry good at it.
- 6) The BRICS summit was unanimous in condemning Israel for the holocaust in Gaza and now in Beirut. The world is in condemnation of Israel as an apartheid state committing ethnic cleansing. This Jerusalem will never be a glory in all the earth. It is condemned by all the earth. At some point the evangelical world is going to come to the realization this is not the Jerusalem and Israel that Biblical prophecy is referring to....but the Church is!

If you have ever prayed 1 Timothy 2:1-4.....

1Ti 2:1 I exhort therefore, that, first of all, supplications, prayers, intercessions, and giving of thanks, be made for all men;

1Ti 2:2 For kings, and for all that are in authority; that we may lead a quiet and peaceable life in all godliness and honesty.

1Ti 2:3 For this is good and acceptable in the sight of God our Saviour; 1Ti 2:4 Who will have all men to be saved, and to come unto the knowledge of the truth.

...then the success of the nations aligned in BRICS is an answer to your prayers.

At its core BRICS is not a military or political ideological alliance. It is an economic alliance that needs peace on earth to succeed. That peace is to maintained by respecting multinational sovereignty of nation states, rule of international law, trade not war, sound monetary policies and an end to economic and military dominance.

Which allows we the people of God in all the BRICS nations to lead quiet and peaceable lives in all Godliness and honesty leading people into the Kingdom of God by our living examples.

Instead of looking for apocalypse and Armageddon on earth....trust the message from heaven at the birth of our Savior....."peace on earth and good will to all mankind." That is God's Kingdom eschatology.
